**Seeks to Avoid Market Cap Bias**

By tracking an index that equally weights the largest U.S. equities and rebalancing monthly, GSEW seeks to avoid concentration in the largest names. This approach may allow the fund to participate in a broad range of market cycles and potentially reduce exposure to isolated market incidents.

**Systematic Rebalancing**

To maintain a target equal weight across approximately 500 of the largest U.S. equities, GSEW seeks to track an index that employs a disciplined and systematic monthly rebalancing process. Monthly index rebalancing enables the fund to adjust to market movements and better maintain its equal weighting.

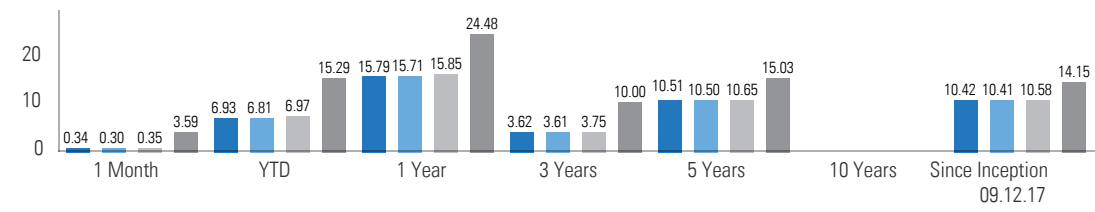

**The Goldman Sachs Equal Weight U.S. Large Cap Equity ETF** (the "Fund") seeks to provide investment results that closely correspond, before fees and expenses, to the performance of the Solactive US Large Cap Equal Weight Index (GTR) (the "Index"), which delivers exposure to equity securities of large capitalization U.S. issuers. The Fund's investments are subject to **market risk**, which means that the value of the securities in which it invests may go up or down in response to the prospects of individual companies, particular sectors or governments and/or general economic conditions.
