Market Value (MV)

Duration is a measure of the sensitivity of a bond's price to changes in interest rates.

Option Adjusted Duration: A measure of the sensitivity of a bond's price to interest-rate changes, assuming that the expected cash flows of the bond may change with interest rates.

"Current Yield" is calculated simply as the coupon of a bond divided by the bond's current price. Current Yield only refers to the yield of a bond (or a portfolio of bonds) at the current moment; it does not reflect the total return over the life of the bond. "WAL (Weighted Average Life)" is the average number of years for which each dollar of unpaid principal on a bond remains outstanding.

YTM is the rate of return anticipated on a bond if it is held until the maturity date. YTM is considered a long-term bond yield expressed as an annual rate.
